





PROCEEDINGS OF THE SPECIAL DEPUTY COMMISSIONER, RAICHUR.

Sub:- Issue of permission to convert the agricultural land to the extent of 3 acres 29 guntas in Sy. No. 873 of Raichur village into non-agricultural purpose for construction of residential houses, educational and other institution. Kannika

Ref:- Application dated 12-8-77 of the Secretary Kannika Parmeshwari Hostel, Raichur.

Preamble :- The Secretary Kannika Parmeshwari Hostel, Raichur has submitted an application regarding permission for conversion of agricultural land bearing Sy. No. 873 measuring 3 acres 29 guntas of Raichur village Raichur taluka for construction of residential houses, educational and other institutions. He has produced the extract of R.O.R. Sketch map, no dues certificate, no tenancy certificate, nil encumbrance certificate in respect of the land.

On receipt of the application, notices calling for objections were issued and reports were called for from all the concerned officers. No objections have been received from all the officers concerned. The details of the reports received from the concerned officers are as shown below.

The land is standing in the name of the committee as could be seen from the extract of the R.O.R. The Tahsildar Raichur has also reported that no form No. 7 under Land Reforms Act is pending and also there is no entry of Sy. No. 873 of Raichur village in the protected tenancy Register maintained in the year 1951. There are no arrears of Government dues in respect of the land in question as per the certificate issued by the Tahsildar Raichur.

The Assistant Director of Town Planning Raichur in his L.No.CHR.ASN.NA/125/17/78/2740 dt. 28-9-77 has reported that there is no objection to issue permission subject to approval of layout from the Assistant Director of Town Planning Raichur and Administrative approval from the Municipality after payment of necessary Development charges as per rules.

The Executive Engineer, PWD Raichur in his L.No.TS.6.Misc. 77-78/4378 dt. 4-10-77 has reported that there is no objection to issue N.A. permission as the said said Sy. No. 873 is situated far away from P.W.D. Road boundary.

The Tahsildar Raichur in his L.o.AIN./7-8/20 dt. 22-10-77 has reported that the land comes within the jurisdiction of Municipality and it is not required for any Government purpose, and that no road passes through the land. He has further stated that no high power transmission line is passing in the land, the applicant is the actual holder of the land, the land is fallow since long, no railway line is passing in the land, no building is constructed on the land and no form No. 7 under Land Reforms Act is pending. Hence the following order is passed.

Permission is hereby accorded for conversion of an area of 3 acres 29 guntas in Sy. No. 873 of Raichur village in Raichur taluka into non agriculture purpose in favor of Sri. Act 1964, subject to the following conditions.
